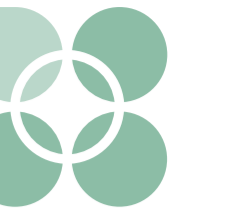

Philanthropic Foundations Canada (PFC) is Canada's national network for grantmakers. A registered charitable organization, we strengthen philanthropy — in all of its diversity — in partnership for a just, equitable and sustainable world.

We are an enabler for the common good, working in collaboration with civil society, the private sector and governments. For more than 20 years, we have been bringing grantmakers together to connect, learn, and advance the best solutions for change on the issues that matter most.

Our members are Canadian grantmakers – composed of private, public, and community foundations, corporate giving programs, donor-advised funds, charitable organizations, and nonprofits. Our members support issues and communities across Canada, and range in asset size, geography, type and funding areas.

What does it take to join?

PFC membership is open to organizations whose primary functions and activities are charitable grantmaking to multiple, unrelated organizations. They must also be:

Registered with the Canada Revenue Agency (CRA) as a:

- **Private or public foundation, or**
- **Charitable organization**

Or, if you are not registered with CRA you must be a:

- **Corporate giving program**
- **Registered nonprofit**

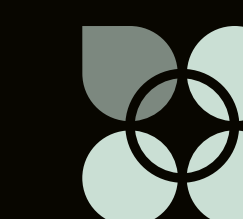
All members must accept [PFC's Purpose Statement](#) and adhere to PFC's [non-solicitation policy](#).

The membership application is an easy three-step online process. [Fill out the membership application](#) and submit your application today!

Members have voting rights and their representative can serve on the PFC board or join committees and taskforces to provide leadership on the strategic directions of the organization.

Membership is valid for one year from January to December, and cost is based on a sliding scale, which can be calculated [here](#).

Grants or direct payments can be made to PFC for membership fees.

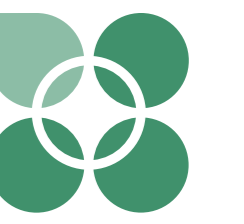

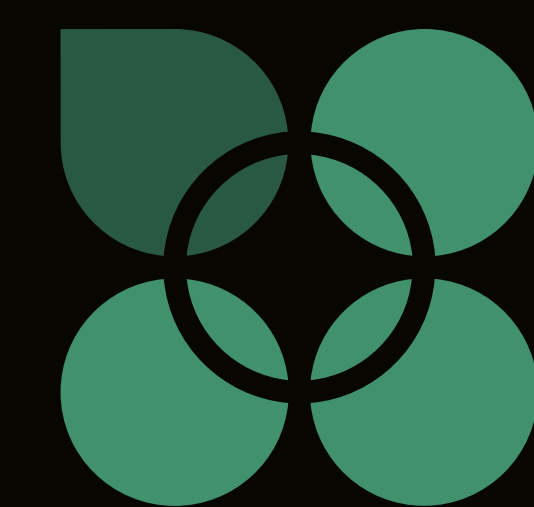
