Message from Chair & President

Purpose, Practice, Partnership. These three themes are at the heart of this year's annual report and at the core of what we do in the network of philanthropy that is Philanthropic Foundations Canada. These three themes shaped the program of our third national conference, held in Calgary in October 2009. And they have shaped the content of our professional development and networking services for members.

During 2009, as the philanthropic sector in Canada began to recover from the severe shock of the financial crisis and economic recession, PFC convened our members to many conversations about our philanthropic purposes, called into question by the great challenges faced by the community. Through these conversations, many members have adopted new practices and formed partnerships to increase their effectiveness and to extend their impact. The lively conversations in the meeting rooms and hallways of the Calgary conference demonstrated clearly to us the value of being part of a network of committed grantmakers, eager to learn and to make real change in Canadian society.

The financial pressure felt by the whole community, including both funders and their beneficiaries, is not likely to improve substantially in 2010. All funders continue to be constrained by deficits or the drop in asset values. Given this difficult outlook, PFC is working harder than ever to showcase stories and experiences of innovative grantmaking and creative philanthropic strategies. We have launched an expanded website in 2010, and will continue to work on new opportunities for grantmakers to learn from each other. In support of better practice, PFC is releasing in 2010 a new guide to good governance for foundations, which we believe will support a move towards more effective governance practices in the field. PFC itself has developed a detailed and disciplined set of governance guidelines, adopted by the PFC Board in early 2010 which we hope will serve as a model for our members.

We owe much thanks to the members of the 2009-2010 PFC Board who steered the association through a challenging but ultimately very successful year. We particularly want to salute and express our appreciation to the following members of the Board retiring in 2010: Jean-Maurice Saulnier of the Lucie et André Chagnon Foundation, Patrick Johnston, formerly of the Walter and Duncan Gordon Foundation, Joy Calkin of the Muttart Foundation, Janis Levine of the Henry and Berenice Kaufmann Foundation and Norman Webster of the R. Howard Webster Foundation. All served for several years on the Board and gave us wise counsel. We are grateful for the spirit of partnership and the commitment to purpose demonstrated by these directors and indeed by all of our volunteer directors on behalf of their peers.

Working for our Members

We continued to work hard on delivering services to members in 2009, focusing on our three principal roles: sharing knowledge to improve effectiveness; advocacy and education; and building the field of philanthropy for all.

McConnell Family Foundation, Montréal Over 200 grantmakers gathered for two days in October 2009 to have informative, stimulating and challenging exchanges at *The Pulse of Philanthropy* conference. We welcomed the participants to Calgary, a dynamic centre of philanthropy in the Canadian West. The conference proved to be a great place to network, to learn and to find new partners, just as our previous gatherings in Toronto and Montreal had been. And it also gave PFC a chance to celebrate in style our tenth year as an association of grantmakers.

Some of the things we heard over and over in the meeting rooms and hallway conversations in Calgary:

- Articulate clear goals and strategies
- Work at multiple levels
- Create a narrative about your work
- Cross boundaries; "think like a watershed"

- Listen as closely as possible to your grantees
- Assess as you go, use the evidence for learning, and for public policy change.

The sessions and topics featured at the conference were a crosssection of innovative and emerging thinking and practice in Canadian philanthropy. Our report on the conference served to disseminate the learnings even more broadly to the field.

Members also engaged in intense conversations and learning during the twelve professional development and peer to peer learning events held in 2009 on topics ranging from mission-related investing to investment strategies to evaluation. Presentations and resources created especially for these topics are posted in the growing members' library available through the PFC web site. All through 2009, we tracked the effects of the financial crisis and recession on our members. Through two surveys in January and in June, we captured and shared with the whole membership the strategies and experiences of various foundations as they coped with the consequences of the economic downturn. This information proved to be very helpful to many boards as they considered their approaches to 2010 investment and grantmaking strategies.

The PFC web site was completely redesigned to make it more up to date and even more accessible to members and non-members. Relaunched in early 2010, it is already attracting more visitors and we hope to have significantly more impact through the site by the end of 2010.

PFC continues to track regulatory policies and changes that could affect the operations and governance of foundations. In 2009, we distributed three member advisories on the regulatory rules with respect to changes to the annual reporting form, to the not-forprofit corporations act and to the excess business holdings regime. PFC also appeared before the Standing Committee on Finance to present a pre-budget submission on behalf of members during the fall of 2009.

In 2010, PFC will be launching the first in a planned series of practice guides. These guides will be available publicly and will address various aspects of foundation management. The first guide will be on foundation governance.


About Our Members

In 2009 we welcomed 9 new members, the largest number in a single year since the association began. PFC numbered 98 members at the end of 2009. The majority are family foundations of varying sizes and interests. Our membership also includes public foundations, corporate foundations, charitable organizations that are primarily grantmakers, and donor-advised funds.

Distribution of Members by Asset Size

Our members collectively manage over \$5.8 billion in assets – about half the total assets of all private foundations in Canada.

51% of PFC members have assets under \$10 million; 21% have assets over \$50 million; the remaining 28% are mid-sized foundations with assets between \$10 M and \$49.9 M.






Grants and Charitable Activities

PFC members granted about \$172 million in 2008. Half of all grants were directed to social services, education and health. Grants to environmental groups represented another 28%. Members also disbursed \$ 119 million directly on foundation-managed charitable programs and activities.
