- In collaboration with the Manager, Operations and Grants Administration, ensure the effective and efficient
  administration and delivery of the granting program, including processes, due diligence, reporting, documentation,
  grant agreements, correspondence, and other communications related to Board decisions and to the fulfillment of
  grant terms.
- In collaboration with the Manager, Operations and Grants Administration, implement a grants management system to support granting approaches, data collection and learning and impact agenda of the Foundation.
