Their thoughtful and compelling insights not only enriched these activities, but underscored the ongoing importance of engaging more diverse leaders across our sector while providing more opportunities for our members and partners to connect to the issues that guide all of our work.

An important lesson from this past year is that we still have so much to learn—as a sector, as a network, as philanthropists, as charities, and as individuals. The pandemic has indisputably confirmed the importance of working together, the value of trust and building relationships, and the need to tackle power imbalances. We are heartened by the conversations that members and partners are having to enhance the impact of their work.

We know that there is much to be done and the priority for 2022 is to build the foundation for this next, (hopefully) post-pandemic era, working alongside our inspiring, diverse, and committed members. Policy and Advocacy

Philanthropic Foundations Canada plays an active role in engaging governments, civil society partners, and influencers to create enabling environments for a more inclusive, resilient, sustainable, and prosperous Canada.

Driven by PFC's purpose to serve the common good, we work hard to align and amplify our efforts in public policy and advocacy based on insights from our research and programs as well as current affairs and external events.

Our current policy priorities are:

- The disbursement quota
- Improving more equitable access to charitable funding by removing direction and control for non-qualified donees
- Increasing impact and mission-related investment
- Fixing the sector's data deficit

Disbursement regulation is at the core of foundation management in Canada, and so when PFC learned about the government's interest in the disbursement quota in early 2021, we quickly sprang into action.

We began by striking a member-led working group to develop an evidence and values based position to recommend to our board of directors. We also partnered with research experts to conduct empirical analysis on the impacts of policy changes on the sector.

Overall, our efforts included surveys, workshops, a CEO retreat, interviews, and focus groups with members, along with dozens of one-on-one conversations with members and sector leaders and two public webinars.

Together these efforts culminated in our submission to the Government of Canada on its Boosting Charitable Spending in Communities consultation.

A central finding was that raising the disbursement quota would be an inadequate measure to improve community access to funding because it does nothing to remedy the existing funding inequities in the sector.

Our position landed on supporting a disbursement quota increase to 5% and that the government should collaborate with the sector on three enabling conditions:

- Improving more equitable access to charitable funding by removing direction and control for non-qualified donees
- Increasing impact and mission-related investment
- Fixing the sector's data deficit

In the **Government of Canada's Budget 2022** and its supplementary information released in April 2022, we noted and welcomed announcements on several key priorities that PFC, our members, and our wider network have been advocating for – including a new disbursement quota of 5%, improvements in the collection of information from charities, and new rules that govern the way that charities are able to partner with and provide funds to non-charities. PFC will continue public engagement and government relations to ensure the details of new sector reforms advance the common good.

Partnerships and Collaboration

PFC 2022-2024 strategic directions has support for collaboration as a new pillar of programming. Below is a selection of two key initiatives that in 2021 we were engage in with our members and networks.



In collaboration with Community Foundations of Canada, Environment Funders Canada, and the Circle on Philanthropy and Aboriginal Peoples in Canada, we launched the <u>Canadian Philanthropy Commitment on Climate Change</u> in fall 2021. The pledge calls on Canadian foundations and other funders to commit to act on climate change regardless of their respective missions.

We know that if left unaddressed, the impacts of climate change can undo our work to advance equity, health, poverty alleviation, economic prosperity, Indigenous, and human rights, especially for those who will be disproportionately affected – and all issues and communities on which we hope to have a positive impact as philanthropic actors.

We work with all interested organizations to support their journeys and provide them with resources, networking, and learning opportunities.

To date, we have close to 50 signatories in Canada joining <u>a global community</u> under the **#PhilanthropyForClimate** movement of more than 500 philanthropic actors committing to act on climate.

COVID-19 Consortium

The COVID Québec Consortium was created in March 2020 and was initially formed by the Jarislowsky, Molson, Saputo, and Trottier foundations and coordinated by PFC. It became a pillar in the fight against the pandemic in the Greater Montréal area and the Chaudière-Appalaches region.

By fall 2021 when the program sunset, **PFC helped 10 foundations** and multiple state actors mobilize **contributions totaling \$12.3M** to support Québec's most affected communities in mitigating the spread and impact of COVID-19.



As the pandemic was unfolding, PFC delivered in-depth analyses to guide the foundations' decisions and investments. PFC's coordination team provided the consortium with knowledge syntheses, analyses, and expert-based recommendations to ensure strategic and impactful investments.

PFC also played a critical role of liaison between the foundations, academia, public health authorities, government representatives at all levels, and more than **200 community organizations**.

Through the **27 community action plans** that it deployed over a territory with **3.3 million residents**, this initiative has been publicly recognized by health officials as playing a key role in stemming the 3rd wave of the pandemic and increasing vaccination in Montréal.


