

2026 PFC Annual Membership Contribution Table

Annual Membership Contributions are determined by a calculation of the three-year average of your organization's assets and the three-year average of your organization's grants. For 2026, the Contribution level is calculated with data from 2021, 2022, and 2023. PFC uses the most recent publicly available reported data from the T3010 (lines 4200, 5045 and 5050) or, alternately, figures from submitted audited financial statements. The minimum Membership Contribution level is \$1,000 CAD.
